

# Stewards of the Coast and Redwoods Annual Report 2019 - 2020



August 25, 2021

Dear fellow Stewards,

My heart is full as I present you with a two-year annual report spanning 2019-2020. In 2019, Stewards was impacted by the effects of fires in Sonoma County, from which we were evacuated, and a flood that impacted our local community of Guerneville. Despite those challenges, we realized many accomplishments including our work with the Sonoma MPA Collaborative to complete a video entitled, *Kashia Pomo Tribal Traditions in the MPA*, the beginning of our Pond Farm Artist-in-Residence program, a new tide pool touch table, and fuel reduction work with volunteers and the Sonoma County Youth Ecology Corps. In concert with so many others, Stewards faced more unexpected and prolonged challenges in 2020, beginning with closed access to all of our parks due to the pandemic, followed by the sweep of the Walbridge wildfire in August, which burned through over 5,000 acres of Austin Creek State Recreation Area and a portion of Armstrong Redwood State Natural Reserve. These back-to-back developments created financial uncertainty for Stewards, impairing our usual income stream from fundraising events, gate revenues and retail sales. In recent months, with concerted effort, including a major commitment to fiscal responsibility, we have begun a strong recovery from these setbacks. Our community of supporters, local businesses, dedicated staff and board have rallied with us to face these challenges and remind us of what we have not lost.

As we continue to recover from 2020, staff and board are building on our current strategic plan to develop specific priorities for the future. The goals that Stewards is setting out to accomplish in the next three to five years include not only fire recovery and preservation of our natural surroundings, but a new vision for the experiences of our visitors and community. 'Impact' has taken on new meaning for us this year, as we address recovery from impacts of fire damage and park closures, in order to realize the impacts we seek in delivering to the communities we serve.

Facility Management and Operations will be a primary focus in the near future. Assessment of the wildfire damage, managing the recovery and rebuilding the infrastructure of Armstrong Redwoods SNR and Austin Creek SRA is a significant task we are working on with our State Parks partners. This includes rehabilitating trails, fencing, bridges and campground facilities.

Future projects include upgrades to the Visitor Center facilities in both Jenner and at Armstrong Redwoods and incorporating bilingual signage throughout the Parks we hold in stewardship. We will focus on accessibility, connecting with the communities we serve and recognizing the indigenous lands on which we sit. These all open up opportunities for Stewards to serve the community in unique and creative ways, incorporating principles of climate resilience and actions to internalize diversity, equity, and inclusion.

Volunteers are the backbone of Stewards. A small staff of highly experienced and dedicated people coordinate the work of hundreds of volunteers who provide school and community-based education, docent-led interpretation of the Redwood Forest, Intertidal, and Marine ecosystems. 2020 and 2021 created an unplanned break in our offerings of environmental education programs that has provided opportunities to update and renew our commitment to our curricula and youth programs. One partnership we are particularly excited about is our continued work with the Sonoma County Youth Ecology Corps (SCYEC). With Stewards serving as the in-park partner managing operations and interpretive programs related to the ecology and natural resources specific to our parks, and SCYEC as the in-community partner, we are connecting youth in need, not only to their parks, but to services that help build bridges to their futures.

In the summer of 2020, Stewards' board and staff made a strong commitment to address Diversity, Equity and Inclusion. A dedicated committee has come together to help us navigate a better future, incorporating DEI across all aspects of our work in the coming years.

As I leave my leadership role with Stewards at the end of 2021, I will always remember how honored I have been to be a part of all that we have accomplished together in the past 27 years and blessed by all the staff and volunteers that I have been fortunate to work with and now consider friends. You have nurtured my heart and soul, for which I will always be grateful.

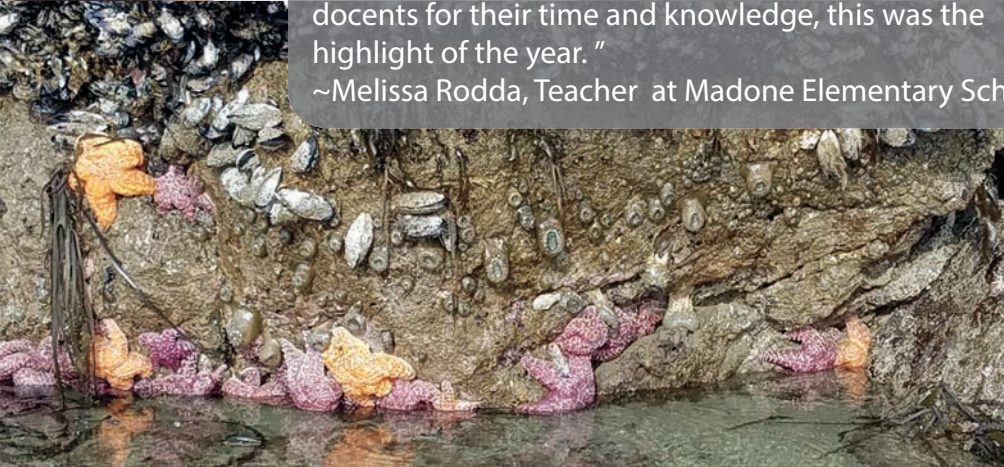

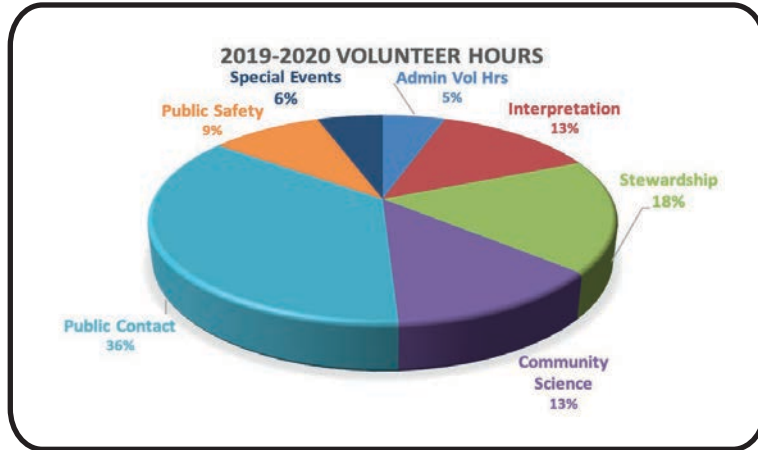

Volunteer participation dropped significantly from 2019 to 2020 due to Covid-19, the Walbridge wildfire and the subsequent closure of Armstrong Redwoods SNR and Austin Creek SRA. Despite these setbacks, volunteers stepped up significantly to assist in fire recovery efforts at Armstrong Redwoods and Austin Creek. Environmental education programs with youth stopped as of March 2020 along with most programs where volunteers interacted with the public. During this time, Stewards maintained ongoing remote communication and engagement with volunteers.

# Operating Your Parks

Visitation at Armstrong Redwoods SNR decreased from 2019 to 2020 because of the devastating Walbridge wildfire that swept through both parks and closed them after August 17, 2020.

A critical initiative for Stewards in partnership with State Parks has been focusing on fuel reduction in order to protect our parklands from the devastation that can be caused by wildland fires. We believe our efforts did help prevent greater damage during the Walbridge fire. By the time the fire reached the forest floor of Armstrong Redwoods, it burned low and slow, and no buildings were lost in that park.



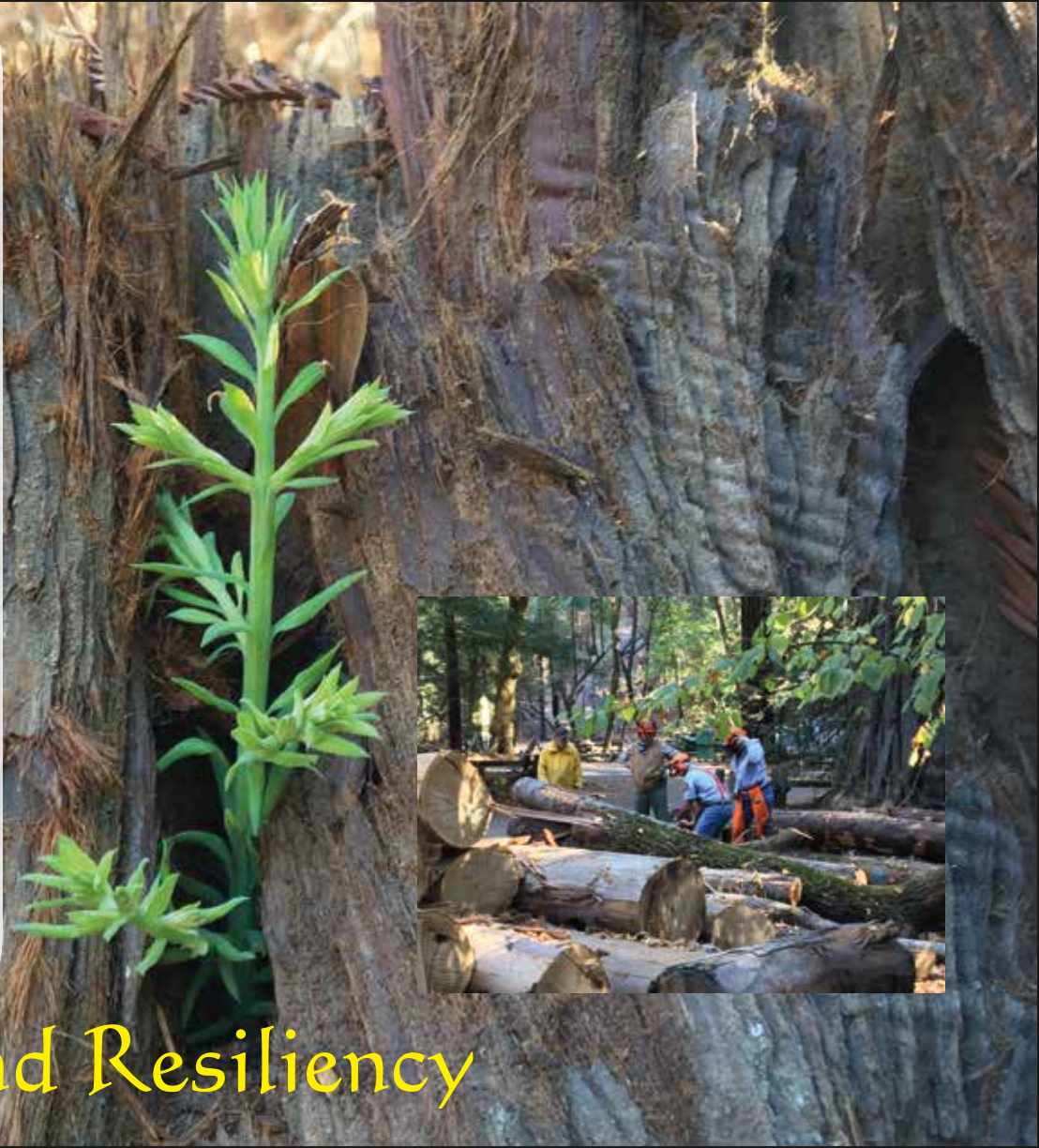
Working together in partnership, Stewards and State Parks tackled the huge job of recovering from the Walbridge Fire. Responsibilities were delineated and each entity reported to one another regularly on their progress, gradually checking off tasks on the punchlist.

### **State Parks - 2020**

- Safety precautions were taken and access to fire areas limited until it was deemed safe.
- Outside agencies were involved with immediate fire cleanup.
- Trees were assessed for fire damage and possible removal.
- Infrastructure damage was documented and utilities were assessed.

### **Stewards - 2020**

- Loss of tools and supplies were reported to our insurance company and replaced.
- Stewards mobilized and trained volunteers for bucking trees and firewood processing.
- Hundreds of trees lost due to the fire began being processed into firewood by staff and volunteers.
- Stewards played a key role in keeping the community updated on fire recovery efforts.

# Collaborating Environmental Partnerships

Stewards is honored to be an active participant in the efforts of these agencies and nonprofit organizations working with us to promote, restore and protect the natural and cultural resources in our State Parks.



Stewards is a founding member of the Sonoma MPA Collaborative, comprised of 30 agencies including scientific institutions, environmental NGOs, tribal governments, and agencies committed to raising awareness of Marine Protected Areas amongst coastal residents and visitors. We have produced 4 videos that highlight different aspects of working, playing, fishing and Kashia tribal traditions in the Sonoma Coast MPAs.



Now that the National Marine Sanctuary System has been expanded into Sonoma Coast waters, Stewards is working closely with the Greater Farallones and Cordell Banks National Marine Sanctuaries to expand outreach and collaborate on programs and events that serve the general public and schools, including Beach Watch.



A partnership with the Bureau of Land Management, the California Coastal National Monument and the Seabird Protection Network has supported Stewards in creating a new Sonoma County Chapter of the Seabird Protection Network including Sea Ranch as well as three monitoring locations on the Sonoma Coast. Community Scientists collect data during the breeding and non-breeding seasons and report disturbances to seabirds to the Seabird Protection Network.



The goal of the Sonoma Environmental Education Collaborative (SEEC) is to increase environmental literacy in Sonoma County. SEEC identifies and addresses regional needs for environmental education, identifies gaps in existing resources and considers how existing resources can be leveraged to achieve common goals.



In 2007, Stewards launched the Pinniped Monitoring Program in partnership with the Sonoma Water. Citizen Scientists collect and provide data used by the National Marine Fisheries Service (NMFS) to ensure that pinnipeds are safeguarded under the Marine Mammal Protection Act at the mouth of the Russian River.

### Recent Accomplishments

- In 2019-2020, we welcomed our first artists-in-residence. Due to the Walbridge Fire, some artists had to be cancelled or postponed.
- Docent tours of Pond Farm took place in 2019 but were cancelled in 2020 due to Covid-19 and the Walbridge Fire.
- Conducted an art program with a home school group at Pond Farm with Pond Farmer Brian Martens.
- Funding was donated to start the Julia Terr Pond Farm Fellowship to fund BIPOC artists to attend the artist-in-residence program at no cost, with an additional stipend to cover related supplies and expenses.
- Supported National Landmark status for Pond Farm Historic District.
- Supported Annual Sunset Dinner, a benefit for Pond Farm in 2019. Cancelled due to Covid-19 in 2020.
