## Armstrong Redwoods State Natural Reserve

The purpose of this position is to assist in the operation of the Visitor Center at Armstrong Redwoods State Natural Reserve and to further the mission of California State Parks: "To provide for the health, inspiration, and education of the people of California by helping to preserve the state's extraordinary biological diversity, protecting its most valued natural and cultural resources, and creating opportunities for high-quality outdoor recreation."

## Duties and Responsibilities:

- Open and close the Visitor Center
- Answer questions and give accurate information to park visitors on the location of facilities, trails, day use areas, campground information, and the natural and cultural history of the area
- Provide quality customer service
- Perform simple sales and accounting of Stewards of the Coast and Redwoods merchandise
- Wear provided name badge and California State Parks Volunteer patch while volunteering
- Keep track of volunteer time

#### Skills and Qualifications:

- Willingness to learn and share significant natural, cultural, and historical facts with the visiting public
- Ability to be courteous
- Knack to offer friendly, accurate, and appropriate assistance to the public whenever possible
- Capacity to work independently as well as cooperatively with Stewards of the Coast and Redwoods staff, State Parks staff, and other volunteers

## Time Commitment:

Three hours per month minimum, year-round. Hours to be arranged.

# Training:

A formal training course of six hours is required to become a Visitor Center volunteer, as well as three sessions of shadowing an experienced volunteer. Bear in Mind EEO Training is required within 60 days of completing the paperwork and subsequently every two years.

## Reporting:

The supervisor for this program is Senior Park and Recreation Specialist, Bill Maslach. The lead for this program is the Stewards of the Coast and Redwoods Program Manager. Amelia Schall Tůmová is the Sonoma-Mendocino Coast District Volunteer Coordinator (Amelia.Schall@parks.ca.gov).
